BMC asks public to report overcharging by pvt hosps

AGENCIES / Mumbai
The BMC has appealed to citizens to bring to its notice if they have been overcharged by private hospitals for the treatment of COVID-19. The civic body last month appointed auditors for various private hospitals after receiving complaints of overcharging by some facilities for coronavirus treatment.

Since then, the auditors have settled 134 complaints pertaining to 26 private hospitals and bill amounts have been collectively reduced by Rs 23.42 lakh, the BMC said in a statement. The total amount charged from all the complainants was Rs 1,61,88,819. After the audit of these bills, the amount was reduced to Rs 1,38,46,705, it said. To ensure private hospitals

charge bills as per the government rates, the BMC said it has appointed two auditors for every private hospital, and also made available to the public some e-mail IDs for registering complaints. The state govt has also appointed five IAS officers to ensure proper distribution of 80 per cent of the beds in private hospitals for the treatment of COVID-19 patients, it said.

RTE ADMISSIONS LIKELY TO BEGIN FROM JUNE 25

With an aim to start the academic year without any delay, admissions under the Right to Education (RTE) Act may begin in 367 schools of Mumbai from June 25, 2020. Around 5,371 students have been selected from 14,135 applications for 7,069 vacant seats this year for RTE admissions in private unaided schools. Currently, the system updation for RTE admissions is under process by the National Informatics Centre (NIC) in Pune. A senior official managing RTE admissions said, "The final data regarding the admission process will be sent to schools by June 24. Following which, we will verify the process and notify all

schools. The admission process may take one more week to start as we are updating the online system." Under the Right to Education (RTE) Act, students from economically weak

sections can seek free and compulsory elementary education from Class 1 to 8 in private unaided schools. Around 25 per cent seats in these schools are reserved for students. Parents apply

online and via mobile app for RTE admissions, seats are allotted through lottery rounds and parents are notified via SMS. The lockdown affected the admission process as the education department had to function with minimum staff, revealed Mahesh Palkar, BMC education officer. Palkar said, "The entire RTE admission process is online. But the lockdown affected the process of verifying applications and managing the selection process as we had to work with minimum staff. We have notified all school principals regarding the admission process." According to the RTE admission guidelines, once parents receive the selection SMS, they will have to visit the respective school

on allotted dates and submit documents for verification. Palkar added, "Schools should make necessary arrangements to conduct collection and verification of documents by maintaining physical distancing and safety measures. Verification of documents such as proof of income is an important step before confirmation of admissions. Parents should visit schools on allotted dates and avoid crowding to prevent risks of spread of coronavirus infection." This year, over 1 lakh students have been selected out of a total of 2.91 lakh applications received for RTE admissions for 1.15 lakh vacant seats in 9,331 schools of Maharashtra. The lottery round was conducted in March.

COVID-19 testing in Maha has doubled: Tope

The number of COVID-19 test laboratories in Maharashtra has increased to 103 and the count of tests per million in the state has now doubled, Public Health Minister Rajesh Tope said on Monday.

According to an official statement here, Tope said that the number of government laboratories in Maharashtra now stands at 60, while the figure for private ones is 43. Among these, Mumbai has 27 (12 government and 15 private ones) laboratories, while Pune has 22 (10 government and 12 private ones). From May 26 to June 20, the number of laboratories has increased by 30, the minister added.

Govt hopeful of budget fund disbursal for schools

MUMBAI: The Maharashtra government is optimistic about disbursing funds approved through supplementary demands during the Budget session for schools and a decision on the issue will be taken during cabinet meeting, Deputy Chief Minister Ajit Pawar said on Monday.

Pawar, who also holds Finance portfolio, held a meeting with some MLAs on issues relating to funds for primary, secondary and higher secondary schools, an official statement said. NCP president Sharad Pawar and the states School Education Minister Varsha Gaikwad also attended the meeting held at Sahyadri Guest House here. The meeting also discussed hardships being faced by teaching and non-teaching staff due to the lockdown.

25-year-old man held for girlfriend's suicide

A day after a 23-year-old Kandivall woman hanged herself, the Samta Nagar police have arrested her boyfriend, Hritik Mishra, on the charges of abatement to suicide. The police have found a suicide note in which the woman has named her boyfriend.

The incident came to light on Saturday morning, when the brother of the woman went to the mezzanine floor of their house to awake his sister, however, he was shocked to found her hanging from an iron rod. The family brought her down and called police. According to the police, in the note, the woman has blamed Mishra for taking the extreme step. In her note, she mentioned that her boyfriend Hritik promised her that he will marry her but he married someone else. The woman further mentioned in her note that because of the accused she could not concentrate on her studies. "Mishra should get punishment for his mistake so that no one else commits suicide because of him," she stated. She also gave names of three persons who knew everything. Following the offence was registered, Mishra was arrested on Sunday. "On her father's complaint we have registered an offence of abatement of suicide (306) of the Indian Penal Code (IPC) and arrested the accused on Sunday, he was produced in the court on Monday which remanded him in police custody," said an officer.

CM, Pawar discuss COVID-19 situation

MUMBAI: Maharashtra Chief Minister Uddhav Thackeray and NCP president Sharad Pawar on Monday discussed the present COVID-19 situation in parts of the state, sources said here. According to the sources, the COVID-19 situation in North Mumbai and Pune in particular came up for discussion during the meeting held at the Bal Thackeray Memorial here. Home Minister Anil Deshmukh and NCP leader Praful Patel were also in attendance, the sources said. Areas in North Mumbai like Malad, Kandivall, Borivali and Dahisar have witnessed a sharp rise in COVID-19 cases recently. Brihanmumbai Municipal Corporation data revealed that the case doubling rate in Borivali was 18 days compared to 34 days for Mumbai as a whole, while neighbouring Dahisar, part of R North Ward, was even worse with numbers doubling every 16 days.

G-South ward officials find innovative ways to fight corona

Coronavirus has not just engaged all officials of different government agencies to take care of health care needs but at the same time also emphasised on introducing innovative measures to contain the spread of the virus. In one such move, the G-South ward, which has plus areas of South Mumbai (SoBo) like Lower Parel, Elphinstone, Prabhadevi, Worli among a few, has installed foot-operated devices that can be used while taking a lift, using wash-basins, toilet flush besides covering the employees cabin with transparent acrylic shield in a bid to protect staffers and frontline warriors from getting in direct

contact with the infected individuals in its office, said Sharad Ughade, G South ward assistant municipal commissioner. He informed, "The innovative technology has been introduced by our own civic department engineers. After

coronavirus, we usually conduct a brainstorming session with the team members wherein we discuss on various ideas and measures to be implemented and that's how the automatic operated devices or those which can be run by merely touching feet

installed in the ward office. Moreover, it is a low-cost solution." Meanwhile, he asserted that apart from working for the citizens they are also taking care of their employees. Recently, G-South ward had installed automatic sanitisation technology in pay and use public toilets. Interestingly, due to innovative measures introduced, this ward which was ranked first in the COVID-19 positive cases as compared to other wards, as of now has 1,091 active cases. While as per the data released by the BMC of June 22, K-East civic ward which comprises areas of Andheri East, Vile Parle, Jageshwar is having the highest number of COVID positive cases. The ward has 2,509 active cases as of now.

Discom consumers dread hefty power bills

Common man is not just suffering from Coronavirus induced pandemic but also grieving over the hefty electricity bills they are receiving from various distribution companies (discoms) like Tata Power, MSED, Torrent, BEST, Adani Electricity etc in June. People who have received high power bills are stunned and believe they have been charged wrongly. Many also stated that despite lockdown their consumption has been similar to the previous month or what was earlier consumed in summer. Swagat Lakku, consumer of discom Torrent, a franchisee of MSED in Kalwa Mumbra, has received a power bill of Rs 13,000 for the last three months. He explained, "Electric consumption in my 2BHK is the same and lockdown need not be a reason for extra consumption as I do not work consistently on my laptop in my work-from-home routine.



A bill of Rs 13,000 is a real electric shock for me, as I usually get a bill of Rs 800/per month which fluctuates between Rs 1800 and Rs 2,000 in summers. A collective bill of Rs 7,000 is something that I had anticipated, but Rs 13,000 is almost double and completely unfair." Lakku asserted that he will reach out to the power supplier and ask them to check if there has been a metre tampering or re-evaluate the bill amount. Similar grievances were expressed by Deepali Kanojia, an MSED consumer and a resident of Kalyan, who said, "My usual bill of Rs 700

was multiplied almost six times and charged Rs 4,600 for three months. All my dues are cleared and the average is not applicable to me, so they should ideally adjust the amount and charge me correctly." MSED Chief Public Relation Official Anil Kamble commented, "Due to lockdown, consumers were asked to avail facility of self metre reading, which was sadly availed by only 2.60 lakh customers of a total 2.70 crore customers across the state. They just had to click a picture of the metre and upload it on website or app, which they failed to do and

hence received an average bill of the previous three months (December, January and February), which are winter months, for consumption in March, April, May (summer months), which was relatively low and an average bill sent was undercharged. Now in June, the uncharged amount is added in June month's bill, which they think is high. However, we are addressing the issues." Likewise, Adani Electricity Mumbai Limited (AEML) consumer Olive Lopez, a resident of Bhayander, has received Rs14,287 bill in which Rs 8,160 showing as the outstanding amount. However, the consumer has told that she has regularly paid bills in February, March, April and May and she has no arrears. AEML's official commented, "We have re-started physical meter reading which was temporarily halted since March because of Covid-19. Bills were generated on lower side being an average of preceding three months i.e. Dec, Jan & Feb, which are

winter months. Actual consumption in the months of Apr, May & June is comparatively higher due to seasonal impact (summer) and increased usage (the advent of lockdown/work from home). Now the consumers will start receiving the bills based on their actual consumption with appropriate tariff slab benefits. The bill amount for the past period shall be accounted for as per MERC guidelines." Meanwhile Energy expert Ashok Pendse, who is also a MERC-approved consumer representative, said, "As people were confined in their homes due to lockdown the electricity consumption increased. Many used gadgets for WFH and used ACs in summer. There has been no mismanagement from discoms, but the consumers are baffled due to the average bill and addition of uncharged amount for three months. I suggest consumers should be given an equated monthly installment (EMI) provision to pay the big amount of bills."
